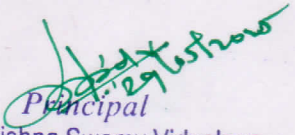
2. OBJECTS OF THE TRUST:

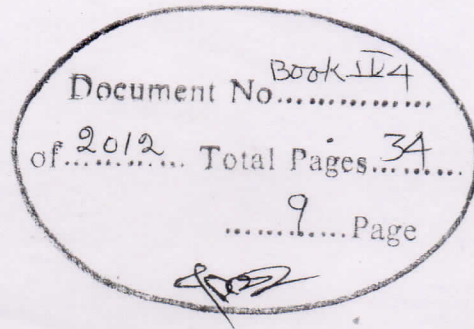

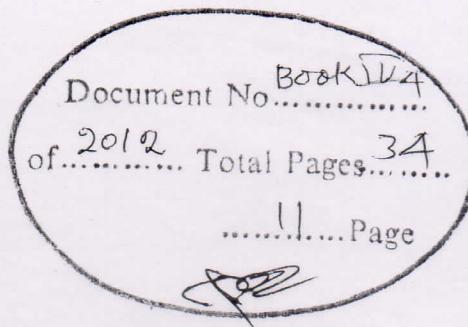
3. THE PROPERTIES OF THE TRUST:

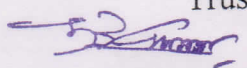
4. QUALIFICATION FOR TRUSTEESHIP:

5. ENTRANCE FEE:

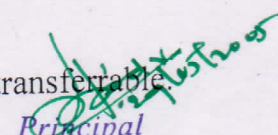
After registration of the Trust, the General body of the Trust has to be fixed the entrance fee.

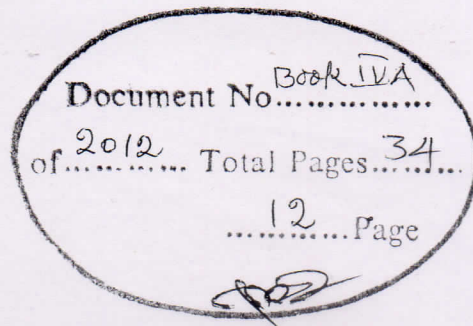

6. CESSATION OF TRUSTEESHIP:

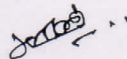
Under the following circumstances the Trustee ship of the Trust shall cease his/her Trusteeship.

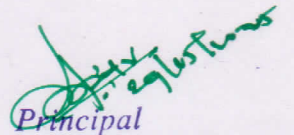
- a. On receipt of written resignation.
- b. If a Trustee is found guilty of breach of the constitution his/her Trusteeship shall be terminated after giving due notice and hearing to the Trustee by the Board of Trustees.
- c. If a Trustee is absent for three consecutive meetings without any valid reasons.
- d. Before being expelled thus, he should be issued a notice giving him a reasonable opportunity of 15 days to defend his case. On expiry of the above period a decision must be made convening the Board of Trustees.
- e. The expelled Trustee may appeal to the Board of Trustees of the Trust within 15 days. The final decision on the appeal petition can be made by the president only after getting majority in the Board of Trustees.
